## SAMPLE ENTRIES FOR APA-STYLE REFERENCES PAGE

A Reference List cites works that specifically support your paper. The references are placed in alphabetical order by authors' last name. Each item is indented five spaces for each line after the first one. Entries are double-spaced.

The In-Text citation identifies the source so that the reader may locate the full information in the Reference List. All Reference List items must be cited in the text. Always give page numbers for quotations and, if used, cite specific chapters. (Spitz, 2006, p.60)

### BOOKS

*Important elements: author, date (use n.d. when no publication date is available), title, edition (if stated), place of publication, publisher.*

#### Book with one author

Spitz, Ellen Handler. (2006). *The brightening glance: imagination and childhood.*

New York: Pantheon Books.

In-text citation: (Spitz, 2006)

#### Book with group author

*In the following example the association is both author and publisher.*

American Psychiatric Association. (1994). *Diagnostic and statistical manual of mental disorders* (4<sup>th</sup> ed.).

Washington, DC: Author

In-text citation: (American Psychiatric Association. *Diagnostic and statistical manual of mental disorders*,1994).

*Cite the name of the association and the name of the manual in full at the first mention in the text: thereafter, you may refer to the manual as follows:*

*DSM-IV* (1994) fourth edition or *DSM-IV-TR* (2000) text revision.

### **Book with multiple authors**

Schwartz, D., Ryan, S., & Wostbrock, F. (1995). *The encyclopedia of TV game shows*. New York: Facts on File.

In-text citation: (Schwartz, Ryan, & Wostbrock, 1995). *List all the authors' names for the first reference. If more than six authors list first author and abbreviate remaining authors et al.*

### **Book with an editor**

Dudley, W. (Ed.). (2002). *Religion in America: Opposing viewpoints*. San Diego, CA: Greenhaven.

In-text citation: (Dudley, 2002)

### **Book with no author named**

*The bluebook: A uniform system of citation* (17<sup>th</sup> ed.). (2000) Cambridge, MA: Harvard Law Review Association.

In-text citation: (The bluebook, 2000). *Use a short title or the full title if it is short.*

### **Article within a Book**

Cassel, J., & Zambella, B. (1996). Without a net: Supporting ourselves in a tremulous atmosphere. In T. W. Leonhardt (Ed.), *“LOEX” of the West: Teaching and learning in a climate of constant change* (pp.75-92). Greenwich, CT: JAI Press Inc.

### **Encyclopedias and other multi-volume works**

### **Article or chapter in an edited book, two editors**

### **Electronic Book**

## **PERIODICALS**

*Important elements: Author, Date of publication, Article title, Journal title, Volume and issue number of the journal, page numbers of the article.*

### **Journal article, one author**

Mellers, B. A. (2000). Choice and the relative pleasure of consequences. *Psychological Bulletin*, 126, 910-924.

In-text citation: (Mellers, 2000)

### **Journal article, two authors, journal paginated by issue\***

Klimoski, R., & Palamer, S. (1993). The ADA and the hiring process in organizations. *Consulting Psychology Journal: Practice and Research*, 45(2), 10-36.

\*Include issue # in parentheses immediately after the volume. Issue # is **not** in italics.

### **Journal article, three to six authors**

Saywitz, K.J., Mannarino, A.P., Berliner, L., & Cohen, J.A. (2000). Treatment for sexually abused children and adolescents. *American Psychologist*, 55, 1040-1049.

In-text citation: (Saywitz, Mannarino, Berliner, & Cohen, 2000)

### **Journal article, more than six authors**

Wolchik, S.A., West, S.G., Sandler, I.N., Tein, J., Coatsworth, D., Lengua, L., et al. (2000). An experimental evaluation of theory-based mother and mother-child programs for children of divorce. *Journal of Consulting and Clinical Psychology*, 68, 843-856.

In-text citation: (Wolchik et al., 2000).

### **Journal article from Internet-only journal**

*Additional elements: date of access, web site address.*

### **Journal – entire issue or special section**

Barlow, D. H. (Ed.). (1991). Diagnoses, dimensions, and DSM-IV: The science of classification [Special issue]. *Journal of Abnormal Psychology*, 100(3).

In-text citation: (Barlow, 1991)

### **Journal article from a database**

Additional elements: date of access, and database name (JSTOR in this example).

In-text citation: (Holton, 1994)

### **Newspaper article**

Newman, Maria. (2006, May 1). Immigrants stage protests across U. S. *The New York Times*, pp. A1, A4.

In-text citation: (Newman, 2006)

### **Magazine article**

## **WEB SOURCES**

*Important elements: author (if no author, begin the reference with the title of the document), date (use n.d. when publication date is not available), title of work, group responsible for site, date of access, and address of the site.*

### **Stand alone documents.**

National Park Service. (2003, February 11). *Abraham Lincoln Birthplace National Historic Site*. Retrieved February 13, 2003, from <http://www.nps.gov/abli/>

In-text citation: (National Park Service [NPA], 2003) *In later National Park Service citations refer to NPA.*

### **Document available on a university Web site**

## **CITING A WORK DISCUSSED IN A SECONDARY SOURCE**

*Give the secondary source in the reference list: in text, name the original work, and give a citation for the secondary source. (Publication Manual of the American Psychological Association, p.247)*

Reference list entry: (this is the entire document or book)

Coltheart, M., Curtis, B., Atkins, P., & Haller, M. (1993). Models of reading aloud:

Dual-route and parallel-distributed-processing approaches. *Psychological Review*, *100*, 589-608.

In-text citation: (the reference cited in the text of the above document )

Seidenberg and McClelland's study (as cited in Coltheart, Curtis, Atkins, & Haller, 1993)
